Incomplete Applications and Non-Payments Will Not Be Considered. This Application is not an offer or a guarantee of space. Within 10 business days of GWCO's receipt of your completed application, you will receive an email notification of your application status of approval/non-approval status. Approved vendors will receive another email with move in instructions closer to the event. Non-approved vendors will receive a full refund. **Space assignments are at the discretion of the Event Planner, with the success of ALL vendors and the event as the top priority.**

Conditions for 2022

1. **NO other agent or person will serve as a representative of the GWCOG and sell/manage vendors for this event. Vendor Management is handled in-house and is being organized by the staff (Tracey, Missy and Corrine). Should you have questions or concerns, please contact GWCOG, who is the ONLY promoter/owner of these events at 609-729-4000 or info@gwcoc.org.**
2. All locations will be assigned by GWCOG. While written requests will be considered, placement is at the sole discretion of GWCOG committee.
3. Exhibitor/Concessionaire parking is provided in designated areas only. With the exception of specified set-up/load-in and break-down/load-out time, vehicles will **not** be permitted at the event site. Vehicles are to be removed immediately when asked by GWCOG staff.
4. Food vendors MUST provide a Certificate of Insurance to their application.
5. All Vendors are required to keep a neat, presentable booth at all times. Empty boxes will not be permitted around the booth. Tents MUST be secured by weights.
6. It is the sole responsibility of each vendor to obtain the applicable and appropriate state and local licenses and permits as well as payment of taxes pertaining to their operation. Food Vendors should expect inspection of food operations by Cape May County Health Department and City of Wildwood Fire Department. Vendors are responsible for fees associated with such inspections. The City of Wildwood Fire Permit is included in this packet. Please complete and return to the City of Wildwood with the permit fee of \$54.
7. A limited number of electrical hook-ups will be available at the Fox Park event. You must include that on your application. We will **NOT** take day of request. Please bring extension cords. Byrne Plaza events must have quiet generators.
8. Booths MUST remain open till the end of the event.
9. Vendors must remove & dispose of all trash from their designated location at the end of the festival day. Nothing is to be left behind.
10. At no time should food vendors dispose of cooking oil or hot coals at the festival site. Anyone caught doing so will not be invited back and will be reported to the proper authorities.
11. All sidewalks at the Food & Music Festival **must** remain clear of vendor supplies & trash.
12. Although GWCOG does not offer an exclusive vending option, we try our best to limit the sale of like items. Vendors will only be permitted to sell the items listed on their application.

GWCOG will do our best to market all of these events to the public in the effort to make this a successful event for all involved. GWCOG spends over \$60,000.00 annual in advertising for our events. We ask that you help spread the word too – Facebook, twitter, personal invites to friends and family members. Our success is your success.
